Jen West, Carbon West, Carbon Industry Overview

- The Carbon Industry Overview was prepared by Carbon West on behalf of the WA Landcare Network and Gondwana Link to bring people up to speed on the opportunity carbon farming brings.
- The overview was designed to assist group landcare officers dealing with landowners.
- Started by keeping a directory of people who could help but realised that people needed to know what's what before who's who.
- The overview goes back to basics providing carbon 101 for people starting in the field.
- Particularly it defines some of the complex terminology used in carbon farming and where the landowner fits in.
- Passionate about ensuring that landowners have their eyes wide open as far as this industry is concerned.
- Lots of opportunity and an industry that has a good intention so maximizing potential for ecological good it important.
- The overview was a start and still working on some more tailored 101s including soil carbon.
- Exciting times in carbon. There is lots happening at a State and Federal level and over the last 12 months there has been an enormous enquiries.

- The Carbon Care Voices Report is weighty, lot of research and a lot of data extremely useful resource.
- We need carbon influencers, we need to normalize people's perceptions. Carbon framing is still a specialised field at the moment. We want everyone to have an understanding of what their on-farm carbon emissions inventory is.
- It is important that everyone have an understanding of terminology and have carbon literacy.
- We need a collectively understanding of what we need through more forums so that we can then bring the same message out to landowner groups.
- Response in the under 39 age group showed that this group was less interested. Maybe an anomaly or may require relevant social science research.
- Carbon participation is currently low.
- Barriers
 - lack of stable government policy,
 - financial viability of project partners,
 - o encumbrances such as having land tied up.
- Motivators
 - Landowners want to see over existing projects to get an understanding of how they work.
 Keen to see demonstration sites. WALN can help with a list of people willing to have people come and have a look over their project.
 - Having better access to markets and understanding what drives consumers is also important
 - Clear education and understanding of terminology
 - Stable policies and a clear road
